Students who are inappropriately dressed will not be permitted into classes. Tuition is taken monthly. The tuition fee does not include fees for rehearsals, school uniform, costumes, competitions, workshops or summer school programs or year end video cost. For students who are participating in performances extra rehearsals as well as stage rehearsals are mandatory. Withdrawal from classes/programs requires 30 days written notice.
